Entry Restrictions	Directors, officers, management, employees and other staff (and the immediate families of directors, officers, management, employees and other staff) of the Promoter or of its related bodies corporate, or of the agencies or companies associated with this Competition are not eligible for entry. Entrants must provide a valid email address and contact details when entering the Competition, and be over the age of 18 years old at the time of the entry to be eligible to win a prize
Competition Period	The Competition commences at 07:00 21 August 2026 (Sydney time) and closes at 23:59 on 21 st July 2027(Sydney time).
